In accordance with our current three year CBA, attached are revised rate sheets effective November 1, 2011. These rate sheets will be in effect for the six months ending April 30, 2012. The revised rate sheets give effect to an increase in the journeyman rate of \$1.29. This amount is then prorated for various other worker categories.

As you recall the CBA contemplates the current apprentice program moving from a three year to a four year program. All apprentices currently enrolled remain in the three year program. New apprentices, as they come on board, will be placed into four year programs. The Union Education Office will inform you as to when new apprentices are to be paid in accordance with the four year program. If you ever have a question on this, call the Union Education Office in Springfield.
